

ITINERARY

February 20 – Depart the USA

February 21 – Arrive Tel Aviv & Transfer to Bethlehem

You will be welcomed at the Tel Aviv airport by our representative and transferred to your hotel to enjoy dinner before retiring for the night.

February 22 – Kings of Israel

Begin your tour in the Holy Land by visiting the Herodion, the fortified palace and final resting place of Herod the Great. In Bethlehem, gaze out over Shepherds' Field and visit the cave revered as Jesus' birthplace (Matt. 1: 18-25). Visit the Church of the Nativity, where the cave revered as Jesus' birthplace resides in the world's oldest functioning church (Matt. 1: 18-25). Overnight in Jerusalem.

February 23 – The Wilderness Experience

Stop in Jericho, the oldest known inhabited city in the world. Visit the ruins of the ancient city, which was conquered by Joshua (Josh. 6: 1,2,20) and see parts of the ancient city walls which have been uncovered. Visit Qumran, site of the Dead Sea Scroll discovery, to discuss the mysterious community of Essenes who once lived on the shores of the Dead Sea. Experience the baptism in the Jordan River. Stop briefly at the Shores of the Dead Sea for a quick dip in the salt and mineral-laden waters. Overnight in Jerusalem.

February 24 – Jesus' Ministry in the Galilee

Cross the waters of the Sea of Galilee on a very special boat ride, complete with an onboard worship service. Visit Capernaum, the center of Jesus' ministry in the Galilee, and visit the synagogue built on the site where Jesus taught (Matt.4:13, 2). Explore the Church of the Loaves and Fish at Tabgha, the traditional site of the feeding of the 5,000 (Luke 9:10). On the Mount of Beatitudes, contemplate the "Sermon on the Mount" (Matt. 5-7). Dinner and overnight in Jerusalem.

February 25 – Jesus in Jerusalem

Visit Mount Zion and stand in the Upper Room (John 13), near the traditional site of the Last Supper (Mark 14). Walk through some of the ancient rooms of Caiaphas, the High Priest's house beneath the Church of St. Peter in Gallicantu. Here, Jesus was held overnight before His crucifixion (Luke 22). Visit the Temple Mount, once the site of the Temple of Solomon. Take time to pray at the Western Wall. Sit on the Teaching Steps where Jesus once taught.

February 26 - The Week that Shook the World

Stand atop the Mount of Olives as Jesus did and enjoy a remarkable view of the "Golden City" of Jerusalem. Forty days after his resurrection, Jesus ascended into heaven from the Mount of Olives (Acts 1: 9-12). Pray in the Garden of Gethsemane (Matthew 26) among olive trees in the Kidron Valley across from the walls of Jerusalem. View the Pool of Bethesda, where Jesus performed the Sabbath miracle (John 5: 1-31). Sing a hymn in the Church of St. Anne, known for its amazing acoustics. Visit Herod's Antonia Fortress, where Jesus was brought before Pontius Pilate (Luke 23: 1-11). Walk the Via Dolorosa, "the Way of the Cross," and stand in reverence at the Church of the Holy Sepulchre. Your final destination allows time for reflection at the Garden Tomb. Enjoy dinner tonight before transferring to the airport for your return flight.

February 27 – Return Home

Arrive home with a new understanding of the Bible, the land and the life of Jesus!



Drs. Samuel & Nohemí Pagán




Dr. Samuel Pagán is a recognized Latin American scholar who has dedicated his life to the study, the translation, and interpretation of the Bible. He has written more than fifty-four books and hundreds of theological articles, both pastoral and biblical; in addition, he has

edited various study Bibles. His books on the Psalms and on Jesus of Nazareth have become classics in a short time among seminary students, pastors and laymen. Also, his studies on Don Quijote have gardnered him international fame and several recognitions in various academic circles in both Latin America and Europe. His recent book, <u>Hacia un Liderato Transformador</u> (Toward Transforming Leadership), is captivating leaders and churches which are developing evangelistic leaders in future generations. At the present, he is Dean of Hispanic Programs at the Jerusalem Center for Biblical Studies.

Dra. Nohemí Pagán is professor of education and spirituality, authoress of children's books, and editor of theological literature. Her most recent book, <u>Perfectamente Diferentes</u> (<u>Perfectly Different</u>), has rapidly become popular in Christian communities in the USA, Puerto Rico, and Latin America; a resource that every church should have to address the issue of children with special needs.
